Dear Mr. Evers,

This responds to your August 17, 2020, Freedom of Information Act request in which you seek records described below:

Copies of SF-50 forms and resumes for any employees who entered a position at, or changed positions within, the immediate\* Office of the Postmaster General and CEO from June 15, 2020 to the present.

To date, we have identified fourteen (14) pages of record material responsive to your request. The following exemptions apply to the redacted documents, as explained below:

### **FOIA Exemption 6**

FOIA Exemption 6 permits withholding documents where release of personnel and similar files would constitute a clearly unwarranted invasion of personal privacy. Any records that contain information concerning individuals may qualify for the exemption's protection. Once records qualify for the application of Exemption 6, the agency must balance the privacy interests of the individuals involved against the public interest, if any, that would be served by disclosure. *Department of the Air Force v. Rose*, 425 U.S. 352, 372 (1976); *National Association of Retired Federal Employees v. Horner*, 879 F.2d 873, 874 (D.C. Cir. 1989), *cert. denied*, 494 U.S. 1078 (1990). Exemption 6 protects the privacy interests of government employees as well as private individuals. See, e.g., *Ripskis v. Dep't of Housing and Urban Development*, 746 F.2d 1, 3 (D.C. Cir. 1984). If a document can be released with the exempt private information redacted it should be redacted and released.

Here, the information contained in the responsive documents meets the threshold for Exemption 6. The Postal Service considers some of the information contained in these documents to be public information. See Postal Service Handbook AS-353, Section 5.2(b), *available at* [https://about.usps.com/handbooks/as353/as353c5\\_002.htm](https://about.usps.com/handbooks/as353/as353c5_002.htm). Individuals accordingly do not have a privacy interest in this information and to the extent this information appears in the responsive records, we are disclosing this information. However, other personal information contained in these forms is not public. Individuals have a more than de minimis privacy interest in this information and disclosing most of this additional information would serve no public interest and would not shed light on the operations of the Postal Service. The only exception to this finding is

that some of the information contained in these individuals' resumes would contribute to the public's understanding of the activities of the Postal Service. Specifically, the public has an interest in knowing whether government employees are qualified to hold their respective positions. However, this public interest only outweighs individual privacy interests with respect to information that sheds light on the qualifications of a postal employee. Other information contained in these individuals' resumes, such as the details of prior positions, is withheld under to Exemption 6 because the public interest does not outweigh the individual privacy interest with respect to this information.

If you are not satisfied with the response to this request, you may file an administrative appeal within 90 days of the date of this response letter by writing to the General Counsel U.S. Postal Service 475 L'Enfant Plaza SW Washington, DC 20260 or via email at [FOIAAppeal@usps.gov](mailto:FOIAAppeal@usps.gov). Your appeal must be postmarked or electronically transmitted within 90 days of the date of the response to your request. The letter of appeal should include, as applicable:


- (1) A copy of the request, of any notification of denial or other action, and of any other related correspondence;
- (2) The FOIA tracking number assigned to the request;
- (3) A statement of the action, or failure to act, from which the appeal is taken;
- (4) A statement identifying the specific redactions to responsive records that the requester is challenging;
- (5) A statement of the relief sought; and
- (6) A statement of the reasons why the requester believes the action or failure to act is erroneous.
