This email seeks to narrow or clarify your request to avoid the production of and potential charges for responsive information that you are not interested in receiving. If the OOG does not receive a response from you by the 61st day after the date this email is sent, your request will be considered withdrawn. See Gov't Code § 552.222(d), (g).
