I have not received a response to my last two emails requesting a status update on my client's pending FOIA request. That FOIA request was initiated over seven months ago, on January 13, 2020. Since then, I have followed up with you by phone and email at least monthly, and often multiple times a month, inquiring about the status of our request and questioning the delay. At times you responded to my emails and calls. More often, you have chosen not to. Two months ago, on May 22, 2020, Mr. Ricketts informed me that my client's FOIA request was "currently in review status." Despite my emails since then, that was the last I heard from you on this matter.

At this point, we have come to the unfortunate conclusion that the requested documents will not be forthcoming without further legal action on our part. Therefore, unless we receive a substantive response to our FOIA including the requested documents by this coming Monday, July 27, 2020, we will take all necessary and appropriate action, including filing a complaint in order to expedite receipt the documents we requested pursuant to FOIA in January and seeking all fees and costs available.

We sincerely hope you can provide the requested documents by Monday. I hope to hear from you soon. Nothing in this email is intended to or does waive any of my client's rights as to the pending FOIA request or other matters.
