Details:

On Sunday, 10/21/2012 at approximately 11:09 am, the Brookfield (WI) Police Department (BPD) received reports of an active shooter and shots fired inside the AZANA SALON AND DAY SPA, 200 N. Moorland Road, Brookfield, WI. Upon arrival, BPD officers were confronted with a dynamic, chaotic scene. They discovered that 7 people had been shot, including 3 who suffered fatal injuries and died at the scene. In the immediate aftermath of the shooting, BPD was unable to locate the suspect.

Locating the suspect was a priority considering the shooting was located directly across the street from Brookfield Square Mall, a densely populated area of Waukesha County, WI. The BPD requested mutual aide from surrounding law enforcement agencies, including the FBI Milwaukee Division.

FBI MW, including the Crisis Management Team, SWAT Team, Crisis Negotiation Team, Victim/Witness Specialist and Violent Crime Squad responded to the scene to support BPD.

As the investigation continued, BPD determined that the shooting was likely the result of a domestic violence situation between the suspect, RADCLIFFE HAUGHTON and his estranged wife, ZINA HAUGHTON. RADCLIFFE HAUGHTON entered the salon, located his wife and in the process opened fire with a handgun. He killed 3 people, including ZINA HAUGHTON, MAELYN M. LIND and CARY L. ROBUCK. He also wounded 4 others before barricading himself in an upstairs room and fatally shooting himself.

FBI MW provided tactical and crisis management support. In addition, FBI MW supported the BPD's investigation with personnel to conduct victim/witness interviews.

additional shot fired. stated that she could also smell smoke, the fire/smoke alarms were activated and she could hear crying coming from downstairs.
While on the phone with the police dispatcher, the dispatcher advised her that the shooter had left the building and her and the others should exit the building. was afraid and refused. She requested a police escort out. The dispatcher reiterated that they should exit the building. again refused and she was placed on hold. When the dispatcher returned, she advised that the police were in the building and they should exit the room. advised they exited the room and did not see the police. As they approached the stairs, the police started to give them commands.
stated that as she was walking down the stairs, the sprinkler system was activated and she could see blood mixing with water on the 1st floor. At the bottom of the stairs she observed a co-worker, Carrie LNU, described as a W/F, upper 30s, 5'05-5'06, medium build with short blond hair laying face down and blood underneath her. She observed another co-worker, Maylene LNU, described as a W/F, mid 40s, 5'07-5'08, medium build with redish/brown hair laying face down near another entry door to the upper level stated that she followed the police commands, exited the building and was escorted over to the MCDONALD's restaurant next door.
stated that she was aware of one co-worker that was having marital problems. The co-worker was Zina LNU, described as a W/F, in her 40s, with long, dark brown hair. Her husband, described as a B/M, whose name started with the letter "R" slashed her vehicle's tires at work approximately 1 week ago. indicated that Zina had a lost a lot of weight, approximately 80 pounds over the last year. Her husband was jealous and thought that she was cheating on him. Zina was currently staying at an unknown hotel, with LNU described as vears old.
stated that when she arrived at work she observed Maylene, Zina, and a new girl in the building. When she was evacuated from the building she observed

the new girl and an older woman she did not know outside.



Sergeant requested assistance from the FBI, Milwaukee

Division, at the scene of a mass shooting at the Azana Salon and Spa, across from the Brookfield Mall, in Brookfield. Specific FBI assistance was requested with crisis management and victim affairs. At the time of the request, the shooter was still at large and had not been positively identified.

ASAC Jones notified SAC Teresa L. Carlson, FBIHQ via SIOC, and alerted FBI Milwaukee Crisis Management Team members. E-mail notifications to SIOC and to all responding personnel are attached

At approximately 4:45 p.m., the subject identified as responsible for the shooting, Radcliffe F. Haughton, date of birth 12/17/1966, was located in the salon, deceased. Brookfield Police continued to investigate the shooting as a domestic violence and homicide matter, and no federal nexus was identified.

FBI personnel continue to support the Brookfield Police Department in the case via the Domestic Police Cooperation classification, but no additional substantive investigation is anticipated.

Situation: At approximately 11:15 a.m. on 10/21/2012 CDT, a lone gunman entered the Azana Salon in Brookfield, Wisconsin, and began shooting at employees and patrons of the salon. Three individuals are confirmed deceased, and four others are wounded. The subject ultimately went upstairs in the salon, and is believed to have died of a self-inflicted gunshot wound. At this time, the subject has tentatively been identified by his driver's license photograph. FBI SABT remains on scene pending the resolution of an item that is strapped to the subject's waist.

There was a history of domestic violence between the subject and his estranged wife. The subject was arrested in the past week for slashing his estranged wife's tires. There were no active warrants for the subject at the time of the shooting. Investigation has determined that the subject was dropped off at the scene by a taxi.

Person of Interest/Subject:
