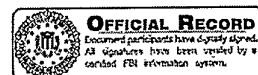

**Synopsis:** (U) To initiate a Domestic Police Cooperation (Violent Crime) investigation in support of the Brookfield (WI) Police Department's investigation into the mass shooting at the Azana Salon and Day Spa, 200 N. Moorland Road, Brookfield, Wisconsin.

**Details:**

On Sunday, 10/21/2012 at approximately 11:09 am, the Brookfield (WI) Police Department (BPD) received reports of an active shooter and shots fired inside the AZANA SALON AND DAY SPA, 200 N. Moorland Road, Brookfield, WI. Upon arrival, BPD officers were confronted with a dynamic, chaotic scene. They discovered that 7 people had been shot, including 3 who suffered fatal injuries and died at the scene. In the immediate aftermath of the shooting, BPD was unable to locate the suspect.

Locating the suspect was a priority considering the shooting was located directly across the street from Brookfield Square Mall, a densely populated area of Waukesha County, WI. The BPD requested mutual aid from surrounding law enforcement agencies, including the FBI Milwaukee Division.

FBI MW, including the Crisis Management Team, SWAT Team, Crisis Negotiation Team, Victim/Witness Specialist and Violent Crime Squad responded to the scene to support BPD.

As the investigation continued, BPD determined that the shooting was likely the result of a domestic violence situation between the suspect, RADCLIFFE HAUGHTON and his estranged wife, ZINA HAUGHTON. RADCLIFFE HAUGHTON entered the salon, located his wife and in the process opened fire with a handgun. He killed 3 people, including ZINA HAUGHTON, MAELYN M. LIND and CARY L. ROBUCK. He also wounded 4 others before barricading himself in an upstairs room and fatally shooting himself.

FBI MW provided tactical and crisis management support. In addition, FBI MW supported the BPD's investigation with personnel to conduct victim/witness interviews.

[redacted] indicated that she has been employed by AZANA SALON & SPA, 200 N. Moorland Boulevard, Brookfield, Wisconsin for approximately 7 years as an [redacted]. On Sunday, 10/21/2012, she was scheduled to work. The business did not officially until 11:00 am, but she arrived for work and entered the establishment at approximately 10:50 am. [redacted] indicated that her first client was not due until 11:15 am. As a result, she talked to a couple of co-workers before going upstairs to her room.

At approximately 11:10 am, [redacted] heard a commotion down stairs and heard her co-workers screaming. She stated it sounded like a negotiation followed by "no, no, no." She also heard an unknown male yelling "Get down, get down." [redacted] became fearful and exited her room. She ran down the hallway and told another co-worker, [redacted] Last Name Unknown (LNU) they had to get out of the building and call 911. [redacted] client, [redacted] LNU all ran down the hallway and went into the "Tranquility Room." [redacted] stated they did not believe that they could safely exit the building and they knew the "Tranquility Room" had a lock on the door. They locked the door and barricaded it with furniture. She stated that the "Tranquility Room" was on the northeast side of the building overlooking the parking lot.

[redacted] subsequently called 911. While on the phone with the dispatcher she could hear muffled commotion downstairs followed by approximately 6 gun shots. Moments later, she observed the police arrive outside. Approximately 3 to 4 minutes after the first shots were fired, [redacted] heard one

additional shot fired. [REDACTED] stated that she could also smell smoke, the fire/smoke alarms were activated and she could hear crying coming from downstairs.

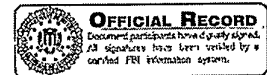
While on the phone with the police dispatcher, the dispatcher advised her that the shooter had left the building and her and the others should exit the building. [REDACTED] was afraid and refused. She requested a police escort out. The dispatcher reiterated that they should exit the building. [REDACTED] again refused and she was placed on hold. When the dispatcher returned, she advised [REDACTED] that the police were in the building and they should exit the room. [REDACTED] advised they exited the room and did not see the police. As they approached the stairs, the police started to give them commands.

[REDACTED] stated that as she was walking down the stairs, the sprinkler system was activated and she could see blood mixing with water on the 1<sup>st</sup> floor. At the bottom of the stairs she observed a co-worker, Carrie LNU, described as a W/F, upper 30s, 5'05-5'06, medium build with short blond hair laying face down and blood underneath her. She observed another co-worker, Maylene LNU, described as a W/F, mid 40s, 5'07-5'08, medium build with redish/brown hair laying face down near another entry door to the upper level. [REDACTED] stated that she followed the police commands, exited the building and was escorted over to the MCDONALD's restaurant next door.

[REDACTED] stated that she was aware of one co-worker that was having marital problems. The co-worker was Zina LNU, described as a W/F, in her 40s, with long, dark brown hair. Her husband, described as a B/M, whose name started with the letter "R" slashed her vehicle's tires at work approximately 1 week ago. [REDACTED] indicated that Zina had lost a lot of weight, approximately 80 pounds over the last year. Her husband was jealous and thought that she was cheating on him. Zina was currently staying at an unknown hotel, with [REDACTED] LNU described as [REDACTED] years old, [REDACTED]

[REDACTED] stated that both Zina and [REDACTED] were already at work she arrived at 10:50 am.

[REDACTED] stated that when she arrived at work she observed [REDACTED] Maylene, Zina, [REDACTED] and a new girl in the building. When she was evacuated from the building she observed [REDACTED] the new girl and an older woman she did not know outside.

[redacted] is a [redacted] at AZANA SALON AND SPA and arrived to work at 10:45 AM on October 21, 2012. [redacted] first appointment was scheduled for 11:15 AM and at approximately 11:00 AM, she went to "log in" in the makeup area of the salon. [redacted] identified the makeup area as being located in the northeast corner of the first floor of the salon (Agent Note: The interviewing SAs constructed a diagram of the salon with [redacted] input and a copy of this diagram and a copy of the interview notes are attached to this report. The original sketch and interview notes are contained in the FBI case file). While in the makeup area, [redacted] overheard ZENA (phonetic) Last Name Unknown (LNU) say something to the effect of "this is a salon, you don't need to be here." ZENA LNU may have also said something to the effect of "we don't have any money here." [redacted] turned towards ZENA LNU's location which [redacted] described as being located south of the salon's front door, on the east side of the building. [redacted] observed whom she described as an unknown black male (UBM) with a bigger build wearing a camouflage jacket, dark pants, and possibly a hat (Agent Note: [redacted] initially described seeing a camouflage "blur") grabbing ZENA LNU's hair. [redacted] only observed the side of his face.

[redacted] instinctively dropped to the floor and hid under a desk. [redacted] then heard six to seven gunshots that were spaced approximately one second between shots. [redacted] also heard other women screaming. [redacted] did not hear shell casings hit the floor. [redacted] observed an unidentified female (UF-1) wearing white socks crouched under ZENA LNU's chair. [redacted] did not observe the shooter pulling the trigger and she did not know if the shooter was alone. [redacted] did not observe any customers in the lobby area. [redacted] later peeked around the corner and observed the UBM outside the building with a black and white, possibly zebra colored backpack. [redacted]

[REDACTED] observed law enforcement (LE), who she described as dressed in olive green clothing and carrying a rifle, enter the building at approximately 11:15 - 11:20 AM. At that time, [REDACTED] heard "gushing" water and the smoke alarms. [REDACTED] was instructed by LE to exit the building and she complied. Once outside the building, [REDACTED] and another unidentified female (UF-2) sat in the back of a LE sport utility vehicle. As [REDACTED] and UF-2 were driven away from the salon, [REDACTED] observed an unidentified female (UF-3) who had been shot and was on the ground being attended to by an unidentified female (UF-4) who indicated she was a nurse.

At approximately 11:45 a.m. on 10/21/2012, ASAC G.B. Jones spoke telephonically with Brookfield, Wisconsin Police Department Sergeant [REDACTED]. Sergeant [REDACTED] requested assistance from the FBI, Milwaukee Division, at the scene of a mass shooting at the Azana Salon and Spa, across from the Brookfield Mall, in Brookfield. Specific FBI assistance was requested with crisis management and victim affairs. At the time of the request, the shooter was still at large and had not been positively identified.

At approximately 4:45 p.m., the subject identified as responsible for the shooting, Radcliffe F. Haughton, date of birth 12/17/1966, was located in the salon, deceased. Brookfield Police continued to investigate the shooting as a domestic violence and homicide matter, and no federal nexus was identified.

FBI personnel continue to support the Brookfield Police Department in the case via the Domestic Police Cooperation classification, but no additional substantive investigation is anticipated.
