Dear Mr. Matthew Hurd:

We represent Huawei Technologies Co., Ltd. and Huawei Device USA Inc. (collectively, "Huawei"). This is an appeal from the Department of Justice, Criminal Division's ("Criminal Division") failure to respond in a timely manner to our Freedom of Information Act ("FOIA") Request (CRM-300696368), originally filed on Huawei's behalf on May 1, 2019. A copy of our original FOIA Request is attached hereto as Exhibit A. This appeal is filed pursuant to 5 U.S.C. § 552(a)(6) on the grounds that the Criminal Division has failed to adequately respond to our request within 20 business days, as required under FOIA.

The FOIA Request pertains to a matter of significant public interest. The indictment issued in *United States v. Huawei Technologies Co., Ltd., et al.*, 18-CR-457 (S-2) (AMD) (the "EDNY Indictment"), the arrest of Ms. Meng Wanzhou, and 5G technology and related competition have been the subjects of widespread and exceptional media interest. Further, the information sought by the FOIA Request involves questions about the government's integrity that affect public confidence, as well as matters of general public and economic interest.

STATEMENT OF FACTS

On May 1, 2019, Huawei submitted a FOIA request to the Criminal Division (Exhibit A), receipt of which was acknowledged on May 10, 2019 (Exhibit B). The Criminal Division designated our request as complex, claiming an additional 10 days to respond under FOIA. In July 2019, having received no update on the status of our request, my colleague Tessa Roberts contacted Amanda Jones, Chief of the FOIA/PA Unit, and asked if there was anything we could do to assist the Criminal Division with the processing of our request (Exhibit C). In response, during a phone call on July 12, 2019, Ms. Jones agreed to request a log of responsive documents from the various Criminal Division components, and informed Ms. Roberts that her team could identify the highest priority documents for initial processing.

After a series of follow-up emails regarding the status of our request between July 2019 and November 2019, on November 5, 2019, Ms. Jones informed Ms. Roberts that a search for electronic records had commenced for "certain custodians, but not all" and that they were "still collecting search information from other portions of the Criminal Division" (Exhibit C). In response, in a November 6, 2019 email, Ms. Roberts reminded Ms. Jones that based on the July 12, 2019 phone call, we had hoped to receive a log of responsive documents that would enable us to select high priority documents and proceed as efficiently as possible (Exhibit C). Ms. Jones never responded.

Our final communication from the Criminal Division was received on November 12, 2019, which simply reiterated that our request was designated as "complex," and that, on average, "it takes the FOIA/PA Unit 203 days to process a complex request." The letter continued, "your request has been pending for 119 business days. A search for responsive records is pending" (Exhibit D).

BASIS OF APPEAL

Under 5 U.S.C. § 552, an agency must make a determination within 20 business days of receiving the FOIA request, or 30 business days in the case of "unusual circumstances." To make a determination, an agency must at least: (i) gather and review documents; (ii) determine and communicate the scope of the documents it intends to produce and withhold and the reasons for withholding any documents; and (iii) inform the requester that it can appeal whatever portion of the determination is adverse. Citizens for Responsibility & Ethics in Washington v. Fed. Election Comm'n, 711 F.3d 180, 189 (D.C. Cir. 2013). No such determination has been made with respect to the Criminal Division FOIA Request. Where, as here, an agency fails to make a timely determination in response to a FOIA request, the requesting party may file an administrative appeal.

Given the extended lapse of time, we ask that the Criminal Division be directed to fulfill the Criminal Division FOIA Request forthwith.
