Dear Austin Evers:

This responds to your Freedom of Information Act request, dated and received in this Office on April 6, 2020 in which you requested records of (1) Attorney General Barr's calendars and (2) incoming and outgoing telephone calls of Attorney General Barr, dating from May 15, 2019.

Please be advised that initial searches have been conducted and records responsive to your request have been located. At this time, I have determined that eighty-seven pages containing records responsive to your request are appropriate for release with excisions made pursuant to Exemptions 6, 7(E) and 7(F) of the FOIA, 5 U.S.C. § 552(b)(6), (b)(7)(E), and (b)(7)(F). Exemption 6 pertains to information the release of which would constitute a clearly unwarranted invasion of personal privacy. Exemption 7(E) pertains to records or information compiled for law enforcement purposes, the release of which would disclose certain techniques and procedures or guidelines for law enforcement investigations or prosecutions. Exemption 7(F) pertains to records or information compiled for law enforcement purposes, the release of which could reasonably be expected to endanger the life or physical safety of an individual. Please note certain pages contain text that is highlighted; these marking were on the records in their native format and were not made in the course of processing these records in response to this FOIA request.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. § 552(c) (2018). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

This is our second interim response to your Freedom of Information Act request, dated and received in this Office on April 6, 2020 in which you requested records of (1) Attorney General Barr's calendars and (2) incoming and outgoing telephone calls of Attorney General Barr, dating from May 15, 2019.

Previously, we provided you one interim response, on October 9, 2020. At this time, I have determined that fifty-one pages containing records responsive to your request are appropriate for release with excisions made pursuant to Exemptions 3, 5, 6, 7(C), 7(E), 7(F) of the FOIA, 5 U.S.C. § 552(b)(3), (b)(5), (b)(6), (b)(7)(C), (b)(7)(E), and (b)(7)(F). Please note that certain excisions were made on behalf of the Central Intelligence Agency, the Department of State, the Department of Homeland Security, the Federal Bureau of Investigation, and the Federal Emergency Management Agency. Exemption 3 pertains to information specifically exempted by statute, in this instance the Central Intelligence Agency Act of 1949, 50 U.S.C. § 3507 and the National Security Act of 1947, 50 U.S.C. § 3024(i)(1). Exemption 5 pertains to information protected by civil discovery privileges. Exemptions 6 pertains to information the release of which would constitute a clearly unwarranted invasion of personal privacy. Exemption 7(C) pertains to records or information compiled for law enforcement purposes, the release of which could reasonably be expected to constitute an unwarranted invasion of personal privacy. Exemption 7(E) pertains to records or information compiled for law enforcement purposes, the release of which would disclose certain techniques and procedures or guidelines for law enforcement investigations or prosecutions. Exemption 7(F) pertains to records or information compiled for law enforcement purposes, the release of which could reasonably be expected to endanger the life or physical safety of an individual. Please note that certain pages contain text that is highlighted or black boxes with no corresponding FOIA exemption overlay text; these marking were on the records in their native format and were not made in the course of FOIA processing.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. § 552(c)

(2018). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.
