This firm represents the Center for Media and Democracy (“CMD”) in connection with the above-referenced Freedom of Information Act (“FOIA”) request to the Internal Revenue Service (“IRS”). I am writing to appeal the IRS’s response and determination under the FOIA.

On June 18, 2020, CMD submitted a FOIA request seeking copies of all attachments to Part XV, “Grants and Contributions Paid During the Year or Approved for Future Payment,” for the following Form 990 series returns:

1. Asness Family Foundation (2016 990 Form, 2017 990 Form, 2018 990 Form);
2. Barbara and Barre Seid Foundation (2016 990-PF Form, 2017 990-PF Form, 2018 990-PF Form);
3. Diana Davis Spencer Foundation (2016 990-PF Form);
4. Dunn Foundation (2014-PF Form);
5. Fidelity Charitable Gift Fund (2013 990 Form, 2014 990 Form, 2015 990 Form);
6. Jack Miller Family Foundation (2015-PF Form, 2016 990-PF Form, 2017 990-PF Form, 2018 990-PF Form);
7. JM Foundation (2014-PF Form, 2015-PF Form, 2016-PF Form, 2017-PF Form);
8. The Randolph Foundation (2016 990-PF Form, 2017 990-PF Form, 2018 990-PF Form); and
9. The Snider Foundation (2016 990-PF Form).

CMD's FOIA request explicitly stated that the requested attachments to the specified Form 990 series returns "are not currently included with publicly available versions of these forms." CMD indicated that it was willing to pay fees for this request up to a maximum of \$20. A copy of CMD's request is attached hereto as **Exhibit 1**.

On June 30, 2020, the IRS sent a letter confirming that CMD's request was received on June 18, 2020. In it, the IRS stated that records requests that can be processed in accordance with routine, established agency procedures are excluded from disclosure in response to a written FOIA request. The IRS directed CMD to request the records sought using IRS Form 4506-A. As an alternative, the IRS suggested that CMD could visit the organization to inspect the return instead of requesting it from the IRS. A copy of the IRS's letter is attached hereto as **Exhibit 2**.

The notion that the IRS is absolved from responding to CMD's FOIA request by directing it to Form 4506-A is not supported by the law. Courts have explicitly rejected the very argument that the IRS is trying to make; i.e., that FOIA is superseded by the agency's statutory scheme governing disclosure of Forms 990. *See Public.Resource.Org v. United States Internal Revenue Serv.*, 50 F. Supp. 3d 1212, 1216-17 (N.D. Cal. 2014) ("Absent express language or a procedural scheme ostensibly displacing FOIA procedures, section 6104 [which provides that Forms 990 should generally be made available for disclosure] cannot be held to supersede FOIA."). In other words, the IRS is not relieved from producing the requested attachments to Forms 990 in response to CMD's FOIA request simply because there may exist another avenue for obtaining them.

Likewise, the IRS is not absolved from responding to CMD's FOIA request by suggesting that CMD could obtain them directly from the organizations themselves. FOIA *requires* federal agencies to release all non-exempt agency records responsive to a request for production, including IRS Form 990s. 5 U.S.C. § 552(a)(3)(A) (stating the agency "shall make the records promptly available"); *see also Public.Resource.Org*, 50 F. Supp. 3d at 1215 (no dispute that IRS Form 990s are agency records subject to FOIA).

CMD respectfully requests that the IRS respond to this appeal within 20 business days, as required by FOIA and its implementing regulations. *See* 5 U.S.C. §552(a)(6)(A)(ii), 34 C.F.R. § 5.40(c). If the appeal is denied, CMD intends to initiate a lawsuit in order to compel disclosure. Please note that CMD is currently involved in a FOIA lawsuit with the IRS involving a request for the very same types of Form 990 series returns that it seeks here. *See Center for Media and Democracy v. United States Internal Revenue Service*, Case No. 1:20-cv-01010 (D.D.C. Apr. 17, 2020). In that case, the IRS agreed that CMD was entitled to the records requested and subsequently released them to CMD. CMD sincerely hopes to avoid having to file another lawsuit in order to obtain the same types of records the agency itself recently agreed it must produce under the FOIA.

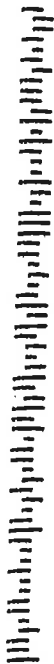

We have a routine agency procedure that should be used to request copies of exempt organization returns. I'm enclosing Form 4506-A, Request for Public Inspection or Copy of Exempt Organization IRS Form. As an alternative, you can visit the organization to inspect the return instead of requesting it from the IRS. Exempt organizations must make their returns available for public inspection.

26 CFR 601.702(d) provides that requests for records processed in accordance with routine agency procedures are specifically excluded from the processing requirements of FOIA.

## General Instructions

### Purpose of Form

Use Form 4506-A to request under section 6104:

- A copy of an exempt or political organization's return, report, notice, or exemption application, or
- An inspection of a return, report, notice, or exemption application at an IRS office.

You **do not** have to complete Form 4506-A to get copies of the following forms

- Form 8871, Political Organization Notice of Section 527 Status, and Form 8872, Political Organization Report of Contributions and Expenditures, are available for inspection and printing from the Internet. The website address for both forms is [www.irs.gov/polorgs](http://www.irs.gov/polorgs).
- Exempt or political organizations must make their returns, reports, notices, and exempt applications available for public inspection. You can visit the organization to inspect the material instead of requesting it from the IRS. The organization may be able to mail the copies to you.
- You may request images of Form 990-N (e-Postcard), for Tax-Exempt Organizations Not Required to File Form 990 or 990-EZ, filings at [www.irs.gov/app/ePostcard](http://www.irs.gov/app/ePostcard).
- The machine readable data for the efiled Forms 990, 990-EZ and 990-PF are available for download from Amazon Web Services (AWS). The website is [www.aws.amazon.com/public-datasets/irs-990/](http://www.aws.amazon.com/public-datasets/irs-990/).
- If you want to determine if charitable contributions are deductible, use Tax Exempt Organization Search, [www.irs.gov/charities-non-profits/tax-exempt-organization-search](http://www.irs.gov/charities-non-profits/tax-exempt-organization-search).

An organization, or its officers, may request a copy of the organization's own return on Form 4506-A. However, they will only receive the copy that is "Open for Public Inspection." The publicly available copy will not include, for example, information that may identify a contributor and documents that were filed with the return, but are not open to public inspection. An organization, or its officers, may request a complete copy of the organization's own return by completing Form 4506, Request for Copy of Tax Return, and paying the applicable fee.

### Digital Data Request

The IRS can provide copies of exempt organization returns on USB. Requesters can order the complete set (for example, all Forms 990 and 990-EZ or all Forms 990-PF filed for a year) or a partial set by state. If you are ordering a partial set on USB, indicate the state(s), and month(s) you are ordering. Sample digital data requests are not available for individual states. Digital data and sample digital data requests are not available for individual exempt organizations. Complete information, including the cost, is available on the IRS website. ### Format

**Raw.** The digital data contain image files in Tag Image File (TIF) format for returns selected for the month or quarter requested. This format is best for users who intend to process the image files through their data software.

### How Much Will It Cost?

You may inspect a return, report, notice, or exemption application at an IRS office free of charge.

If you want a photocopy of a return, report, notice, or an exemption application, see the chart below.

**Note.** The IRS will send you a bill for the photocopy cost. If your cost is over \$250, we will ask for payment in advance.

Routine uses include disclosing the information to the Department of Justice for civil or criminal litigation.
